CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT L. MALLOY 13777 AGATE ROAD EAGLE POINT, OREGON 97524

confirms the right to use the waters of TWO UNNAMED STREAMS AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-8200, tributaries of WILLIAMSON RIVER, for IRRIGATION OF 30.3 ACRES.

This right was perfected under Permit 45301. The date of priority is DECEMBER 10, 1979. This right is limited to 0.76 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RESERVOIR AND UNNAMED STREAM NO. 1 - SE 1/4 SE 1/4, SECTION 10, TOWNSHIP 34 SOUTH, RANGE 7 EAST, W.M.; 850 FEET NORTH AND 600 FEET WEST FROM THE SE CORNER OF SECTION 10;

UNNAMED STREAM NO. 2 - SE 1/4 SE 1/4, SECTION 10, TOWNSHIP 34 SOUTH, RANGE 7 EAST, W.M.; 930 FEET NORTH AND 150 FEET WEST FROM THE SE CORNER OF SECTION 10;

UNNAMED STREAM - SE 1/4 SE 1/4, SECTION 10, TOWNSHIP 34 SOUTH, RANGE 7 EAST, W.M.; 1250 FEET NORTH AND 1320 FEET WEST FROM THE SE CORNER OF SECTION 10; AND

UNNAMED STREAM (PORTABLE PUMPING) SW 1/4 SE 1/4 AND SE 1/4 SE 1/4, SECTION 10, TOWNSHIP 34 SOUTH, RANGE * EAST, W.M.; BETWEEN POINT A LOCATED 930 FEET NORTH AND 150 FEET WEST AND POINT B LOCATED 1250 FEET NORTH AND 220 FEET WEST; BOTH FROM THE SE CORNER OF SECTION 10.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre- for each acre irrigated during the irrigation season of each year from direct flow and storage.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

TOWNSHIP 34 SOUTH, RANGE 7 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
