CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the LOST RIVER BASIN for IRRIGATION OF 25.7 ACRES.

This right was perfected under Permit G-4873. The date of priority is MARCH 24, 1970. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.32 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW% NW%, SECTION 22, T 39 S, R 11 E, W.M.; 440 FEET SOUTH AND 770 FEET EAST FROM THE NW CORNER, SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

A scrivener's error on Certificate 42685 incorrectly described the number of acres irrigated. A subsequent cancellation of a portion of the water right Certificate 42658 caused superseding Certificate 67283 to be issued which carried the error forward.

This certificate correctly describes the number of acres that remain of the original water right.

This certificate describes that portion of the water right confirmed by Certificate 67283, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered ________, approving Transfer Application 9099.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
