CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BONANZA VIEW DAIRY PARTNERSHIP
4721 HARPOLD ROAD
BONANZA, OREGON 97623

confirms the right to use the waters of TWO WELLS in the LOST RIVER BASIN for IRRIGATION OF 118.8 ACRES.

This right was perfected under Permit G-9436. The date of priority is AUGUST 27, 1981. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.485 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 21, NW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 22, T 39 S, R 11 E, W.M.; WELL 1 - 2300 FEET SOUTH AND 140 FEET WEST, WELL 2 - 450 FEET SOUTH AND 800 FEET EAST, BOTH FROM THE NW CORNER, SECTION 22.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. In the event of a request for a change in point of appropriation, an additional point of appropriation, or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 39 SOUTH, RANGE 11 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by Certificate 65493, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered DEC 0 2 2002, approving Transfer Application 9100.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
