CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHUCK AND BILL BRUCE 380 LAKE CREEK LOOP EAGLE POINT, OREGON 97524

confirms the right to use the waters of MAPLE CREEK AND 150.0 ACRE-FEET SUPPLEMENTAL STORAGE IN WADE RESERVOIR UNDER PERMIT R-2706, tributaries of LITTLE BUTTE CREEK, for SUPPLEMENTAL IRRIGATION OF 51.4 ACRES.

This right was perfected under Permit 27726. The date of priority is NOVEMBER 21,1961. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.65 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW¼ SE¼, SECTION 10; NW¼ NE¼, SECTION 11, T 36 S, R 2 E, W.M.; WADE RESERVOIR - 1020 FEET NORTH AND 2540 FEET WEST FROM THE SE CORNER OF SECTION 10; MAPLE CREEK - 480 FEET SOUTH AND 410 FEET EAST FROM THE NORTH ¼ CORNER OF SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4½ acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-2706; the amount allowed herein, together with the amount secured under any other right existing for said lands, shall be limited by the duty of water as fixed herein; provided further that the right to use of direct flow shall be limited to the period when the flow of the Rogue River is more than 1000 cubic feet per second (cfs) at Raygold, more than 1000 cfs immediately above Savage Rapids Dam and more than 735 cfs at its mouth.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
