## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARNOLD J. SCHAEFFER ROUTE 1, BOX 55 WALLOWA, OREGON 97885

confirms the right to use the waters of WALLOWA RIVER, a tributary of the GRANDE RONDE RIVER, for IRRIGATION OF 128.3 ACRES.

This right was perfected under Permit 40889. The date of priority is JULY 16, 1976. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.04 CUBIC FEET PER SECOND, or the equivalent in case of rotation, if available at the original point of diversion: SW¼ NW¼, Section 11, Township 1 North, Range 42 East, W.M.; 860 feet North and 800 feet East from the W¼ corner of Section 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated, and shall be further limited to a diversion not to exceed 3½ acre feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 and OAR 690-001-0005 you may either petition for judicial review or petition the Director for reconsideration of this order.
