	water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not
reunde	exceed 0.30 cubic foot per second or its equivalent in case of rotation. The user shall conform to any reasonable rotation system ordered by the proper state office. A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is us follows:

	The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
