CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CARL F. JENSEN
6532 HOWELL PRAIRIE ROAD
SILVERTON, OREGON 97381

confirms the right to use the waters of A WELL in the LITTLE PUDDING RIVER BASIN for IRRIGATION OF 61.0 ACRES.

This right was perfected under Permit G-6570. The date of priority is SEPTEMBER 10, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.76 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL WELL LOCATED WITHIN THE NW 1/4 SW 1/4, AS PROJECTED WITHIN J. HOWELL DLC 47, SECTION 3, TOWNSHIP 7 SOUTH, RANGE 2 WEST, W.M.; 2630 FEET NORTH AND 1440 FEET EAST FROM THE SW CORNER OF DLC 47), or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN J. HOWELL DLC 47, SECTION 3, TOWNSHIP 7 SOUTH, RANGE 2 WEST, W.M.; 1350 FEET NORTH AND 2260 FEET EAST FROM THE SW CORNER OF DLC 47.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4	2.8 ACRES
NW 1/4 SW 1/4	38.0 ACRES
SW 1/4 SW 1/4	5.4 ACRES

ALL AS PROJECTED WITHIN J. HOWELL DLC 47
SECTION 3

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered AUGUST 13, 2002, and supersedes Certificate 56528, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
