CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CARL F. JENSEN

confirms the right to use the waters of A WELL in the PUDDING RIVER BASIN for IRRIGATION OF 108.5 ACRES.

This right was perfected under Permit G-5837. The date of priority is MAY 25, 1973. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.36 CUBIC FEET PER SECOND (IF AVAILABLE AT THE ORIGINAL WELL DESCRIBED BELOW), or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

ORIGINAL WELL - LOT 4 (SW 1/4 SW 1/4), SECTION 23, TOWNSHIP 5 SOUTH, RANGE 2 WEST, W.M.; 430 FEET NORTH AND 610 FEET EAST FROM THE SW CORNER OF SECTION 23; AND

NEW WELL - NE 1/4 NE 1/4, AS PROJECTED WITHIN BONENFANT DLC 43, SECTION 27, TOWNSHIP 5 SOUTH, RANGE 2 WEST, W.M.; 575 FEET SOUTH AND 370 FEET WEST FROM THE SW CORNER OF SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SE 1/4 23.0 ACRES  
SECTION 22  
TOWNSHIP 5 SOUTH, RANGE 2 WEST, W.M.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change ALLOWING AN ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered AUGUST 13, 2002, and supersedes Certificate 57070, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
