CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of the CLACKAMAS RIVER, a tributary of the WILLAMETTE RIVER, for the purpose of MUNICIPAL USE.

The right has been perfected under Permit 20145. The date of priority is MARCH 15, 1951. The right is limited to not more than 4.0 CUBIC FEET PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION DESCRIBED AS BEING WITHIN THE NE 1/4 NE 1/4, SECTION 30 TOWNSHIP 2 SOUTH, RANGE 2 EAST, W.M.; 650 FEET SOUTH AND 200 FEET WEST FROM THE NE CORNER OF SECTION 30) or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 49, SECTION 16, TOWNSHIP 2 SOUTH, RANGE 2 EAST, W.M.; 2080 FEET SOUTH AND 100 FEET WEST FROM THE NE CORNER OF SECTION 16.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:


Water may be applied to lands which are not specifically described above, provided the holder of this right complies with ORS 540.510(3).

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 29, 1986 and supersedes the right perfected by performance under Permit 20145.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
