CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN M. PRINCE
23556 SW GAGE ROAD
WILSONVILLE, OR 97070

confirms the right to use the waters of A WELL in the NEWLAND CREEK BASIN for IRRIGATION OF 1.0 ACRE.

This right was perfected under Permit G-7349. The date of priority is JULY 28, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 SE 1/4, SECTION 31, TOWNSHIP 2 SOUTH, RANGE 1 EAST, W.M.; 490 FEET NORTH AND 857 FEET WEST FROM THE SE CORNER OF SECTION 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SE 1/4 1.0 ACRE
SECTION 31
TOWNSHIP 2 SOUTH, RANGE 1 EAST, W.M.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF APPROPRIATION approved by an order of the Water Resources Director entered OCTOBER 26, 1999, and together with Certificate 76317, supersedes Certificate 55082, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
