CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT V. GILLETT
ROUTE 2, BOX 184
IRRIGON, OREGON 97844

confirms the right to use the waters of A WELL in the COLUMBIA RIVER BASIN for IRRIGATION OF 31.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.4 ACRES.

This right was perfected under Permit G-7749. The date of priority is AUGUST 10, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.83 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 26, T 5 N, R 26 E, W.M.; 1500 FEET SOUTH AND 650 FEET EAST FROM THE NW CORNER OF SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the well shall be restricted to appropriation of water from the alluvial aquifer and shall not penetrate the underlying basalt estimated to be 110 feet below land surface.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

PRIMARY

SW¼ NW¼ 31.7 ACRES

SUPPLEMENTAL

NW¼ NW¼ 28.2 ACRES

SW¼ NW¼ 6.2 ACRES

SECTION 26


TOWNSHIP 5 NORTH, RANGE 26 EAST, W.M.

This certificate describes that portion of the right confirmed by Certificate 77745, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered JAN 10 2003, and recorded at Special Order Volume 57, Page 15, canceling a portion of the right. This certificate supersedes Certificate 77745.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
