confirms the right to store the waters of SPRINGS AND RUNOFF, TRIBUTARIES OF CAMAS, OWENS AND DEERLICK CREEKS IN TEN RESERVOIRS for LIVESTOCK.

The right to store and use these waters was perfected under Reservoir Application R-77151. The date of priority is January 1, 1993. The amount of water entitled to be stored and used each year under this right is not more than 10.0 ACRE-FEET (AF), BEING 4.7 AF IN RES 21, 1.0 AF IN RES 22, 1.1 AF IN RES 23, 0.7 AF IN RES 24, 0.5 AF IN RES 25, 0.4 AF IN RES 26, 0.3 AF IN RES 27, 0.6 AF IN RES 28, 0.4 AF IN RES 29, 0.3 AF IN RES 30


