## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RANDY HENDERSON 91455 RIVER ROAD JUNCTION CITY, OREGON 97448

confirms the right to use the waters of A WELL (SPRING CREEK), a tributary of WILLAMETTE RIVER, for IRRIGATION OF 25.4 ACRES.

This right was perfected under Permit 28603. The date of priority is MAY 11, 1962. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.32 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL POINTS OF DIVERSION LOCATED WITHIN THE NE 1/4 NW 1/4, AS PROJECTED WITHIN J. BROWN DLC 44, SECTION 35, TOWNSHIP 16 SOUTH, RANGE 4 WEST, W.M.; 200 FEET EAST AND 830 NORTH; 20 FEET WEST AND 1400 FEET NORTH, BOTH FROM THE NW CORNER OF G. MAUPIN DLC 42), or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

WELL - NW 1/4 NE 1/4, AS PROJECTED WITHIN J. BROWN DLC 44, SECTION 35, TOWNSHIP 16 SOUTH RANGE 4 WEST, W.M.; 670 FEET NORTH AND 514 FEET EAST FROM THE NW CORNER OF G. MAUPIN DLC 42.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one suble foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 % acre foot per acre for each acre irrigated during the irrigation season of sach year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state of bigs.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MAY 30, 2002, and supersedes Certificate 33441, State Record of Water Right Certificates.

The issuance of this superseding certificate to so the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water to the lands of place of the above purpose is restricted to beneficial use on the lands of place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows
