CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GRANDE RONDE VALLEY IRRIGATION COMPANY  
205 MAIN STREET  
LA GRANDE, OREGON 97850

confirms the right to use the waters of the GRANDE RONDE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION of 210.0 ACRES.

This right was perfected under Permit 902. The date of priority is JULY 25, 1911. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.63 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 32, TOWNSHIP 2 SOUTH, RANGE 38 EAST, W.M.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 3323, State Record of Water Right Certificates NOT modified by the provisions of orders of the State Engineer entered October 7, 1924 in Special Order Volume 1, Page 140, approving a change in place of use; May 23, 1967, in Special Order recorded in Volume 16, Page 82, canceling a portion of the right; June 26, 1967, in Special Order recorded in Volume 16, Page 156, canceling a portion of the right; and to confirm a changes in point of diversion and place of use approved by an orders of the Water Resources Director entered October 2, 1996, recorded in Special Order Volume 50, Pages 651, 651, 660 through 664 and 668 through 670, Special Order Records of the Water Resources Department approving Transfer Applications No.'s T-7152, T-7361 and T-7400 and supersedes Certificate 79202, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
