CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRIDAY FARMS INC. P.O. BOX 1384 BANDON, OREGON 97411

confirms the right to use the waters of UNNAMED STREAM NO. 1, UNNAMED STREAM NO. 2, SIMPSON CREEK, FERRY CREEK AND RESERVOIRS NO.'S, 1, 2, AND 4 THROUGH 12 CONSTRUCTED UNDER PERMIT R-11418, tributaries of COQUILLE RIVER, for CRANBERRY OPERATIONS ON 78.7 ACRES.

This right was perfected under Permit 51371. The date of priority is JUNE 13, 1988. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.055 CUBIC FOOT PER SECOND (CFS) FROM SIMPSON CREEK DURING THE PERIOD FROM JUNE 1 THROUGH OCTOBER 31 OF EACH YEAR; 0.055 CFS FROM FERRY CREEK DURING THE PERIOD FROM JUNE 1 THROUGH OCTOBER 31 OF EACH YEAR; 0.1 CFS FROM UNNAMED STREAM NO.'S 1 AND 2 THROUGHOUT THE EACH YEAR AND 57.1 ACREFEET STORED WATER ONLY FROM RESERVOIRS NO.'S, 1, 2, AND 4 THROUGH 12 CONSTRUCTED UNDER PERMIT R-11418 THROUGHOUT THE YEAR, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SIMPSON CREEK NO. 1 - NW 1/4 SW 1/4, SECTION 20, TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.; 2570 FEET NORTH AND 990 FEET EAST FROM THE SW CORNER OF SECTION 20;

SIMPSON CREEK NO. 2 - NW 1/4 SE 1/4, SECTION 20, TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.; 1770 FEET NORTH AND 1630 FEET EAST FROM THE SE CORNER OF SECTION 20;

FERRY CREEK - NW 1/4 SW 1/4, SECTION 29, TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.; 3100 FEET SOUTH AND 290 FEET EAST FROM THE NW CORNER OF SECTION 29;

UNNAMED STREAM NO. 1 - NW 1/4 SW 1/4, SECTION 20, TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.; 2270 FEET NORTH AND 1200 FEET EAST FROM THE SW CORNER OF SECTION 20;

UNNAMED STREAM NO. 2 - NE 1/4 SW 1/4, SECTION 20, TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.; 1590 FEET NORTH AND 1910 FEET EAST FROM THE SW CORNER OF SECTION 20;

The amount of water used for CRANBERRY OPERATIONS, together with the amount secured under any other right existing for the same lands as follows: For temperature control, 0.15 cubic foot per second per acre, for flood harvesting or pest control, 0.05 cubic foot per second per acre, for irrigation of cranberries, ONE-FORTIETH of one cubic foot per second per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE- EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
