CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL in the ROCK CREEK (PUDDING RIVER) BASIN for IRRIGATION OF 60.0 ACRES.

This right was perfected under Permit G-2255. The date of priority is JULY 2, 1962. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.51 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF APPROPRIATION DESCRIBED AS BEING LOCATED WITHIN LOT 3 [SW 1/4 NE 1/4], SECTION 25, TOWNSHIP 5 SOUTH, RANGE 1 EAST, W.M.; 1020 FEET SOUTH AND 3580 FEET EAST FROM THE SW CORNER OF JACKSON DLC 38) or its equivalent in case of rotation, measured at the well.

The well is located as follows:

LOT 2 (SE 1/4 NE 1/4), SECTION 26, TOWNSHIP 5 SOUTH, RANGE 1 EAST, W.M.; 990 FEET SOUTH AND 180 FEET WEST FROM THE SE CORNER OF JACKSON DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 % acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NE 1/4 11.0 ACRES LOT 2 (SE 1/4 NE 1/4) 18.5 ACRES NE 1/4 SE 1/4 12.4 ACRES NW 1/4 SE 1/4 18.1 ACRES SECTION 26

TOWNSHIP 5 SOUTH, RANGE 1 EAST, W.M.

When required by the Department the water user shall install an inline flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF APPROPRIATION approved by an order of the Water Resources Director entered JUNE 11, 1993, and supersedes Certificate 35519, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
