CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WAYNE AND MARLENE SCHNELL
80823 DIVISION ROAD
IRRIGON, OREGON 97844

confirms the right to use the waters of A WELL in the UMATILLA BASIN for IRRIGATION OF 20.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 98.0 ACRES.

This right was perfected under Permit G-5248. The date of priority is July 2, 1973. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.37 CUBIC FOOT PER SECOND, or the equivalent in case of rotation, measured at the point of diversion from the well.

The point of appropriation is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or the equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the completed well shall not exceed 50 feet in depth, nor appropriate water from an aquifer below that depth.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This Certificate confirms an order of the Director entered on November 22, 2004, and recorded in Special Order Volume 61, Page 555, approving a petition by West Extension Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate supersedes Water Right Certificate 55596 issued to Wayne H. Schnell.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
