CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 167.2 ACRES AND STOCK WATER.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at Page 436-437. The date of priority is 1906.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.09 CUBIC FEET PER SECOND, subject to the provisions of Paragraph 33 of the decree, or its equivalent in case of rotation, measured at the point of diversion from the source.
