confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 700.5 ACRES.

This right was perfected under Permit 408. The date of priority is MARCH 28, 1909. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 43.07 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, shall be limited to a diversion of not to exceed 2 acre-feet per acre for each acre irrigated during any 30 day period not to exceed 10 acre feet per acre throughout the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
