CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT G. SICARD AND SONS ROUTE 1, BOX 60 BOARDMAN, OREGON 97818

confirms the right to use the waters of WASTE WATER FROM WEST EXTENSION IRRIGATION DISTRICT, a tributary of the COLUMBIA RIVER, for IRRIGATION 15.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 84.8 ACRES.

This right was perfected under Permit 46207. The date of priority is NOVEMBER 28, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.37 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet for each acre irrigated during the irrigation season of each year, and shall also be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
