CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON POTATO, INC.
PO BOX 216
BOARDMAN, OREGON

confirms the right to use the waters of the COLUMBIA RIVER, a tributary of the PACIFIC OCEAN, for SUPPLEMENTAL IRRIGATION OF 50.0 ACRES.

This right was perfected under Permit 31346. The date of priority is SEPTEMBER 23, 1966. This right is limited to 0.86 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

5	N	27	E	W.M.	13	SW NW 4	2380 FEET NORTH AND 350 FEET EAST FROM THE SW CORNER OF SECTION 13

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORIETH of one cubic foot per second (or its equivalent) and 4 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This is an order other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 day time period specified by ORS 183.484(2).

This certificate confirms an order of the Director entered on November 22, 2004, and recorded in Special Order Volume 61, Page 555, approving a petition by West Extension Irrigation District under ORS 541.329, for mapping water rights within a district. This certificate, along with Certificate 79936 supersedes Certificate 53009 of the State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment. The right to the use of the water for the above purposes is restricted to beneficial use on the lands or place of use described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
