## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT G SICARD AND SONS RT 1 BOX 60 BOARDMAN OR 97818

confirms the right to use the waters of WASTE WATER FROM WEST EXTENSION IRRIGATION DISTRICT, a tributary of the COLUMBIA RIVER, for SUPPLEMENTAL IRRIGATION OF 31.5 ACRES.

This right was perfected under Permit 46207. The date of priority is NOVEMBER 28, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.75 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet for each acre irrigated during the irrigation season of each year, and shall also be limited to the water available at the point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This is an order other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 day time period specified by ORS 183.484(2).

This certificate confirms an order of the Director entered on November 22, 2004, and recorded in Special Order Volume 61, Page 555, approving a petition by West Extension Irrigation District under ORS 541.329 for mapping water rights within a district. This certificate, together with Certificate 79937, supersedes Certificate 55958 of the State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said permit.
