CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELLS NO. 2 AND 3 in the WILLAMETTE RIVER BASIN for IRRIGATION OF 44.0 ACRES.

This right was perfected under Permit G-11352. The date of priority is April 29, 1991. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.550 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL NO. 2 - SW 1/4 NW 1/4, AS PROJECTED WITHIN MOORE DLC 66, SECTION 36, TOWNSHIP 11 SOUTH, RANGE 5 WEST, W.M.; 3796 FEET NORTH AND 2573 FEET WEST FROM THE NW CORNER ROBNETT DLC 60; AND

WELL NO. 3 - NW 1/4 SW 1/4, AS PROJECTED WITHIN MOORE DLC 66, SECTION 36, TOWNSHIP 11 SOUTH, RANGE 5 WEST, W.M.; 1368 FEET NORTH AND 3322 FEET WEST FROM THE NW CORNER ROBNETT DLC 60.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

When required by the Department, the wateruser shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of ground water withdrawn.

The Director may require water level or pump test results every ten years.


Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to the use of the water for the above purpose is restricted to beneficial use without waste on the lands or place of use described. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
