## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RONALD AND CAROL DETWEILER 890 ALBERTA AVENUE NYSSA, OR 97913

confirms the right to use the waters of WELLS NO.'S 1 AND 2 in the SHEEP CREEK BASIN for SUPPLEMENTAL IRRIGATION OF 169.5 ACRES.

This right was perfected under Permit G-12547. The date of priority is MAY 3, 1993. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.12 CUBIC FEET PER SECOND(CFS); BEING 1.34 CFS FROM WELL NO. 1 AND 0.78 CFS FROM WELL NO. 2, or its equivalent in case of rotation, measured at the wells. The period of use allowed under this right may be made at any time of the year.

The wells are located as follows:

WELL NO. 1 - SW 1/4 SW 1/4, SECTION 27, TOWNSHIP 19 SOUTH, RANGE 46 EAST, W.M.; 2313 FEET SOUTH AND 1965 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 27; AND

WELL NO. 2 - SW 1/4 SW 1/4, SECTION 27, TOWNSHIP 19 SOUTH, RANGE 46 EAST, W.M.; 1951 FEET SOUTH AND 2323 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 27.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4 9.2 ACRES SE 1/4 NW 1/4 19.3 ACRES NE 1/4 SW 1/4 38.0 ACRES NW 1/4 SW 1/4 39.0 ACRES SW 1/4 SW 1/4 27.0 ACRES SE 1/4 SW 1/4 37.0 ACRES SECTION 27

TOWNSHIP 19 SOUTH, RANGE 46 EAST, W.M.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Measurement, recording and reporting conditions:

- A. The water user shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the water user to report general water use information, including the place and nature of use of water under the right.
- B. The water user shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

If substantial interference with a senior water right occurs due to withdrawal of water from any well listed on this right, then use of water from the well(s) shall be discontinued or reduced and/or the schedule of withdrawal shall be regulated until or unless the Department approves or implements an alternative administrative action to mitigate the interference. The Department encourages junior and senior appropriators to jointly develop plans to mitigate interferences.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon. The works shall be equipped with a usable access port, and may also include an air line and pressure gauge adequate to determine water level elevation in the well at all times.

The Director may require water level or pump test results every ten years.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to the use of the water for the above purpose is restricted to beneficial use without waste on the lands or place of use described. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

Page Three

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The Director finds the use of water described by this right, as conditioned, will not impair or be detrimental to the public interest.
