## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT V. GILLETT ROUTE 2, BOX 184 IRRIGON, OREGON 97844

confirms the right to use the waters of A WELL in the COLUMBIA RIVER BASIN for IRRIGATION OF 26.59 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.4 ACRES.

This right was perfected under Permit G-7749. The date of priority is AUGUST 10, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.77 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW% NW%, SECTION 26, T 5 N, R 26 E, W.M.; 1500 FEET SOUTH AND 650 FEET EAST FROM THE NW CORNER OF SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the well shall be restricted to appropriation of water from the alluvial aquifer and shall not penetrate the underlying basalt estimated to be 110 feet below land surface.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate supersedes Certificate 79854.
