CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROUND PRAIRIE WATER DITCH COMPANY TYGH VALLEY, OREGON 97063

confirms the right to use the waters of THREEMILE CREEK, a tributary of WHITE RIVER, for IRRIGATION 139.45 ACRES.

This right was perfected under Permit 30206. The date of priority is OCTOBER 27, 1964. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.29 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW% NW%, SECTION 11, T 4 S, R 11 E, W.M.; 1530 FEET SOUTH AND 4580 FEET WEST FROM THE NE CORNER, SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
