CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MILTON F. AND JUNE MARTIN
3620 THREEMILE ROAD
THE DALLES, OREGON 97058

confirms the right to use the waters of MARTIN WELL 1, within the THREEMILE CREEK BASIN, for IRRIGATION of 242.34 acres and SUPPLEMENTAL IRRIGATION of 10.0 acres.

This right was perfected under Permit G-482. The date of priority is APRIL 16, 1947. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.18 CUBIC FEET PER SECOND (CFS), PROVIDED FURTHER THAT THE AMOUNT OF WATER ALLOWED HEREIN, TOGETHER WITH THE AMOUNT SECURED FROM MARTIN WELL 2, SHALL NOT EXCEED 2.18 CFS OF WATER OR ITS EQUIVALENT IN CASE OF ROTATION OF WATER OR ITS EQUIVALENT IN CASE OF ROTATION, measured at the well.

The well is located as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 32, T 1 N, R 13 E, W.M.; 750 FEET NORTH AND 1825 FEET WEST FROM THE EAST $\frac{1}{4}$ CORNER OF SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
