CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

L & L FARMS
P.O. BOX 63
STANFIELD, OREGON 97876

confirms the right to use the waters of WELL 3, in the SPIKES GULCH RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 156.5 ACRES.

This right was perfected under Permit G-7036. The date of priority is DECEMBER 2, 1976. This right is limited to not more than 1.67 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

WELL 3 - NW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 23, T 3 N, R 28 E, W.M.; 60 FEET SOUTH AND 820 FEET EAST FROM NW CORNER, SECTION 23.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SW 1/4	29.2 ACRES
NE 1/4 SE 1/4	31.1 ACRES
NW 1/4 SE 1/4	31.2 ACRES
SW 1/4 SE 1/4	32.7 ACRES
SE 1/4 SE 1/4	32.3 ACRES

SECTION 33

TOWNSHIP 3 NORTH, RANGE 28 EAST, W.M.

The water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water used from each well. The type and plans for the measuring device must be approved by the Department prior to using the water at the new place of use. Installation and maintenance shall be under the general supervision of the Department.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director entered MARCH 25, 1998, and together with Certificate 75555, supersedes Certificate 75423, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
