CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WINDING SPRAGUE PARTNERS 4288 E BARNETT RD MEDFORD, OREGON 97504

confirms the right to use the waters of SPRAGUE RIVER, a tributary of WILLIAMSON RIVER, for IRRIGATION OF 275.0 ACRES.

This right was perfected under Permit 44824. The date of priority is DEC 10, 1979. This right is limited to 6.88 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 13 (SW 1/4 NW 1/4), SECTION 16, TOWNSHIP 36 SOUTH, RANGE 12 EAST, W.M.; 2070 FEET SOUTH AND 1320 FEET EAST FROM THE NW CORNER OF SECTION 16;

LOT 14 (SE 1/4 NW 1/4), SECTION 16, TOWNSHIP 36 SOUTH, RANGE 12 EAST, W.M.; 2100 FEET SOUTH AND 1450 FEET EAST FROM THE NW CORNER OF SECTION 16; AND

LOT 14 (SE 1/4 NW 1/4), SECTION 16, TOWNSHIP 36 SOUTH, RANGE 12 EAST, W.M.; 2100 FEET SOUTH AND 2130 FEET EAST FROM THE NW CORNER OF SECTION 16.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.
