## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALLEN L. DOBNEY AND MARTHA M. DOBNEY 43638 SKYE RD. FREMONT, CA 94539

confirms the right to store the waters of RUNOFF, tributary to RIGHT FORK FOOTS CREEK, in UPPER RESERVOIR, for STORM WATER MANAGEMENT, WILDLIFE AND AESTHETICS.

The right to store these waters was perfected under Reservoir Permit R-13253. The date of priority is JULY 23, 2001. The amount of water entitled to be stored each year under this right is not more than 0.03 ACRE-FOOT. The appropriation of water for storage is limited to the period of JANUARY 1 through MARCH 31 of each year.

THE AREA SUBMERGED BY THE RESERVOIR IS LOCATED AS FOLLOWS:

NW 1/4 NW 1/4
SECTION 14
TOWNSHIP 37 SOUTH, RANGE 4 WEST, W.M.

Measurement, recording and reporting conditions:

A. The Director may require the water user to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the water user to install a meter or other measuring device, the water user shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed the water that he water that he water acres to the moter or measuring device in good weeking of der and shall allow the watermaster acress to the moter or measuring device. The Director may provide an of portunity for the water user to submit alternative measuring procedures for review and approval.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

B. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provision of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.

If fish are introduced into the reservoir, the outlet must be screened to prevent reservoir fish from escaping and reaching the free-flowing Umpqua River System. Screen must be 3/32 inch mesh to correspond with NMFS criteria.

The water user shall pass all live flow outside the storage season described above.

This right does not provide for the appropriation of water for any out of reservoir uses, the maintenance of the water level or maintaining a suitable fresh water condition. If any water is used for out of reservoir uses, or any live flow is appropriated to maintain either the water level or a suitable freshwater condition, a secondary water right is required.

## STANDARD CONDITIONS

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrict one on the use, civil penalties, or cancellation of the might.

This right is for the beneficial use of water without waste. The water user is advised that new regulations hav require the use of best practical technologies or conservation tractices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

This right does not authorize the water user to pursue this right in such a way as to interfere with or affect adjacent property not under ownership of the water right holder.

The Director finds the use of water described by this right, as conditioned, will not impair or be detrimental to the public interest.
