This right was perfected under Permit 52030. The date of priority is NOVEMBER 16, 1994. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed

0.011 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source. The period of use allowed under this right is limited to MARCH 1 THROUGH JUNE 30 AND OCTOBER 1 THROUGH OCTOBER 31 of each year.

The point of diversion is located as follows:

LOT 1 (SW 1/4 SE 1/4), SECTION 18, TOWNSHIP 9 SOUTH, RANGE 4 WEST, W.M., 280 FEET SOUTH AND 60 FEET WEST FROM THE NE CORNER OF LOT 1, SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

> SW 1/4 SE 1/4 0.1 ACRE SE 1/4 SE 1/4 0.8 ACRE SECTION 18

ALL AS PROJECTED WITHIN HARVEY STEEPROW DLC 61 TOWNSHIP 9 SOUTH, RANGE 4 WEST, W.M.

Measurement, recording and reporting conditions:

- A. The Director may require the water user to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the water user to install a meter or other measuring device, the water user shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the water user to submit alternative measuring procedures for review and approval.
- B. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

The water user shall be responsible for maintaining the riparian area at the point of diversion to the satisfaction of the Oregon Department of Fish and Wildlife.

The use may be restricted if the quality of the source stream, namely the Willamette River, decreases to the point that it no longer meets state and federal water quality standards due to reduced flows.

The water user shall maintain and operate fish screening and by-pass devices as required by the Oregon Department of Fish and Wildlife to prevent fish from entering the diversion.

STANDARD CONDITIONS

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.
