CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of THE NORTH UMPQUA RIVER, a tributary of THE UMPQUA RIVER, for IRRIGATION OF 154.5 ACRES.

This right was perfected under Permit 50174. The date of priority is AUGUST 19, 1987. This right is limited to 1.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 23, T 26 S, R 6 W, W.M.; 520 FEET SOUTH AND 1120 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 23.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
