CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD P. CREIGHTON

confirms the right to use the waters of LITTLE RIVER, a tributary of NORTH UMPQUA RIVER, for IRRIGATION OF 120.4 ACRES, LIVESTOCK AND DOMESTIC USE FOR TWO FAMILIES.

This right was perfected under Permit 50934. The date of priority is NOVEMBER 8, 1989. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.52 CUBIC FOOT PER SECOND (CFS), BEING 1.505 CFS FOR IRRIGATION, 0.005 CFS FOR LIVESTOCK AND 0.01 CFS FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 30, AS PROJECTED WITHIN J.S. NOLAND DLC 43, TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.; 930 SOUTH AND 250 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 30.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to SECTION 19 which this right is appurtenant is as follows:

Diversion screening or fish passage facilities shall be designed, installed, and operated to Oregon Department of Fish and Wildlife specifications.


Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to the use of the water for the above purpose is restricted to beneficial use without waste on the lands or place of use described. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
