CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

U.S. OCHOCO NATIONAL FOREST

confirms the right to store the waters from TRIBUTARIES OF CROOKED RIVER IN NINE ROBA WEST SYSTEMS RESERVOIRS, being the right to store the waters of EAST BURNT CORRAL CREEK, a tributary of the CROOKED RIVER in COVE RESERVOIR, FAWN RESERVOIR and EAST BURNT RESERVOIR; the right to store the waters from WEST BURNT CORRAL CREEK, a tributary of the CROOKED RIVER in HORSESHOE RESERVOIR, COUGHING HORSE RESERVOIR and WEST BURNT RESERVOIR; the right to store the waters from UNNAMED STREAMS, tributaries of PAULINA CREEK in FLAT RESERVOIR and TANSY RESERVOIR; and the right to store the waters of PAULINA CREEK, a tributary of CROOKED RIVER in MARBLE RESERVOIR; ALL FOR LIVESTOCK WATER.

The right to store these waters was perfected under Reservoir Permit R-10448. The date of priority is OCTOBER 8, 1984. The amount of water entitled to be stored each year under this right is not more than 1.42 ACRE-FEET (AF), BEING 0.23 AF IN COVE RESERVOIR, 0.07 AF IN FAWN RESERVOIR, 0.07 AF IN EAST BURNT RESERVOIR, 0.19 AF IN HORSESHOE RESERVOIR, 0.13 AF IN COUGHING HORSE RESERVOIR, 0.22 AF IN WEST BURNT RESERVOIR, 0.05 AF IN FLAT RESERVOIR, 0.14 AF IN MARBLE RESERVOIR AND 0.32 AF IN TANSY RESERVOIR.
