CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the CHRISTMAS VALLEY BASIN for IRRIGATION OF 240.6 ACRES.

This right was perfected under Permit G-9974. The date of priority is JUNE 9, 1981. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.01 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The well is located as follows;

Well#2 - NW 1/4 NW 1/4, SECTION 35, TOWNSHIP 24 SOUTH, RANGE 18 EAST, W.M.; 1200 FEET SOUTH AND 1250 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
