CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

U.S. WINEMA NATIONAL FOREST 2819 DAHLIA STREET KLAMATH FALLS, OR 97601

confirms the right to use the waters of SQUIRREL CAMP SPRING, a tributary of SELLERS CREEK for LIVESTOCK USE.

This right was perfected under Permit 52759. The date of priority is SEPTEMBER 21, 1983. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.007 CUBIC FOOT PER SECOND, NOT TO EXCEED 4380 GALLONS PER DAY measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 35, TOWNSHIP 25 SOUTH, RANGE 9 EAST, W.M.; 2200 FEET SOUTH AND 1700 FEET EAST FROM THE NW CORNER OF SECTION 35.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 25 SOUTH RANGE 9 EAST, W.M.

SE 1/4 NW 1/4

Measurement, recording and reporting conditions.

A. The Director may require the water user to install a meter or other suitable measuring device is approved by the Director. If the Director notifies the water user to install a meter or other measuring device the water user shall install such device within the period that the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the water shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the water user to submit alternative measuring procedures for review and approval.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

B. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

Failure to comply with any of the provisions of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to the use of the water for the above purpose is restricted to beneficial use without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The Director finds the use of water described by this right, as conditioned, will not impair or be detrimental to the public interest.
