## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EUGENE R. MOE 1010 SE HWY 101 SOUTH NEWPORT, OREGON 97365

confirms the right to use the waters of UNNAMED STREAM AND A RESERVOIR CONSTRUCTED UNDER PERMIT R-8609, a tributary of SILETZ RIVER, for IRRIGATION OF 18.0 ACRES, AND MAINTENANCE OF RESERVOIR FOR STOCK WATER.

This right was perfected under Permit 47438. The date of priority is DECEMBER 22, 1982. This right is limited to 0.225 CUBIC FOOT PER SECOND (CFS), BEING 0.22 CFS FOR IRRIGATION, AND 0.005 CFS FOR MAINTENANCE OF RESERVOIR FOR STOCK WATER or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 4 (NW 1/4 NE 1/4), SECTION 29, TOWNSHIP 9 SOUTH, RANGE 9 WEST, W.M.; 480 FEET SOUTH AND 320 FEET WEST FROM THE NORTHEAST CORNER OF LOT 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-8609.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

LOT 4 (NW 1/4 NE 1/4) 12.1 ACRES STOCK WATER

LOT 5 (NE 1/4 NW 1/4) 3.5 ACRES

TOWNSHIP 9 SOUTH, RANGE 9 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
