CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CITY OF STAYTON  
362 NORTH 3<sup>RD</sup> AVENUE  
STAYTON, OREGON 97383

confirms the right to use the waters of NORTH SANTIAM RIVER, a tributary of SANTIAM RIVER, for MUNICIPAL USE.

This right was perfected under Permit E-82. The date of priority is MAY 14, 1909. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.78 CUBIC FOOT PER SECOND NOT TO EXCEED 779.5 ACRE-FEET PER YEAR, or its equivalent in case of rotation, measured at the point of diversion from the source. The use of water under this right is limited to the irrigation season being May 1 through September 30 of each year.

The point of diversion is located as follows:

LOT 2 (SW 1/4 SE 1/4), SECTION 11, TOWNSHIP 9 SOUTH, RANGE 1 WEST, W.M.; 1800 FEET SOUTH AND 2830 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 11.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

When in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

The diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the user is entitled; and

The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.


TOWNSHIP 9 SOUTH, RANGE 1 WEST, W.M.

This certificate is issued to confirm a change in CHANGE IN USE approved by an order of the Water Resources Director entered FEBRUARY 17, 1987, and supersedes Certificate 52506, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
