CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD KIRKHAM 9225 STEEL BRIDGE ROAD SHERIDAN, OREGON 97378

confirms the right to use the waters of the SOUTH YAMHILL RIVER, a tributary of the YAMHILL RIVER, for IRRIGATION OF 56.2 ACRES.

This right was perfected under Permit 40025. The date of priority is APRIL 23, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.70 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE% NW%, AS PROJECTED WITHIN HAGGARD DLC 94, SECTION 6, T 6 S, R 6 W, W.M.; 1 - 3300 FEET NORTH AND 2100 FEET EAST FROM THE SW CORNER OF SECTION 6.

NE¼ NE¼, AS PROJECTED WITHIN HAGGARD DLC 94, SECTION 12, T 6 S, R 7 W, W.M.; 2 - 620 FEET SOUTH AND 160 FEET WEST FROM THE NE CORNER OF SECTION 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
