confirms the right to use the waters of the SOUTH FORK YAMHILL RIVER, a tributary of the YAMHILL RIVER, to maintain instream flows for FISH, WILDLIFE, AND WATER QUALITY ENHANCEMENT.

This right was perfected under Permit 40025. The date of priority is APRIL 23, 1975. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.2025 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source, during the period JUNE 1 TO SEPTEMBER 9 of each year.

The point of diversion is located as follows:

SE% NW%, AS PROJECTED WITHIN HAGGARD DLC 94, SECTION 6, T 6 S, R 6 W, W.M.; 1 - 3300 FEET NORTH AND 2100 FEET EAST FROM THE SW CORNER OF SECTION 6.

A description of the place of use to which this right is appurtenant is as follows:

From the authorized point of diversion in the SE% NW%, AS PROJECTED WITHIN HAGGARD DLC 94, SECTION 6, T 6 S, R 6 W, W.M.; 3300 FEET NORTH AND 2100 FEET EAST FROM THE SW CORNER OF SECTION 6, to the mouth of the SOUTH YAMHILL RIVER in the SW% NE%, SECTION 14, T 4 S, R 4 W, W.M..

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.
