CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JEAN ANN AND KENNETH TURNER
ROUTE 2, BOX 2218
HEPPNER, OREGON 97836

confirms the right to use the waters of A WELL within the SAND HOLLOW BASIN for IRRIGATION OF 129.0 ACRES.

This right was perfected under Permit G-8903. The date of priority is NOVEMBER 7, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.61 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 19, T 1 S, R 27 E, W.M.; 1070 FEET SOUTH AND 20 FEET WEST FROM NE CORNER, SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
