CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN WALCH
LAKE CREEK, OREGON 97524

confirms the right to use the waters of LOST CREEK AND WATER STORED IN LOST LAKE RESERVOIR, TO BE CONSTRUCTED UNDER PERMIT R-427, a tributary of SOUTH FORK LITTLE BUTTE, for IRRIGATION, SUPPLEMENTAL IRRIGATION, AND DOMESTIC.

This right was perfected under Permit 3733. The date of priority is FEBRUARY 16, 1918. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.647 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


