CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CLAYTON MCCULLOUGH 8399 ROANOKE DRIVE NE BROOKS, OREGON 97305

confirms the right to use the waters of TWO WELLS in the LITTLE PUDDING RIVER BASIN for IRRIGATION OF 5.1 ACRES.

This right was perfected under Permit G-2445. The date of priority is JUNE 20, 1963. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.06 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The quantity of water appropriated at the new well together with that appropriated from the old well shall not exceed the quantity of water available at the original well under the subject right.

The wells are located as follows:

- 1 NW% NE%, SECTION 14, T 6 S, R 2 W, W.M.; 1320 FEET SOUTH AND 1300 FEET EAST FROM THE SW CORNER OF WEBB DLC 56.
- 2 LOT 1 (NE% NE%), SECTION 14, T 6 S, R 2 W, W.M.; 1193 FEET SOUTH AND 935 FEET WEST FROM THE NE CORNER OF SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
