# CERTIFICATE OF WATER RIGHT

## THIS CERTIFICATE ISSUED TO

PLEASANT VIEW IRRIGATION COMPANY c/o WALLA WALLA IRRIGATION DISTRICT 605 LAMB STREET MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of the LITTLE WALLA WALLA RIVER, a tributary of the WALLA WALLA RIVER, for IRRIGATION of 520.7 ACRES.

This right was perfected under Permit 1216. The date of priority is MARCH 25, 1912. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 6.512 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE¼ SE¼, SECTION 35, T 6 N, R 35 E, WM; 5 FEET NORTH AND 1100 FEET WEST FROM THE SE CORNER, SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
