# CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELL NO. 4 in the ROCK CREEK BASIN for IRRIGATION OF 1.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 2.8 ACRES.

This right was perfected under Permit G-3952. The date of priority is JANUARY 17, 1968. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.05 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW¼ SE¼, SECTION 15, T 2 S, R 22 E, W.M.; 50 FEET NORTH AND 2480 FEET WEST FROM SE CORNER, SECTION 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
