CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

H. G. TRASS P.O. BOX 55 CAMP SHERMAN, OREGON 97730

confirms the right to use the waters of A WELL in the FORT ROCK BASIN for IRRIGATION OF 10.0 ACRES.

This right was perfected under Permit G-9137. The date of priority is DECEMBER 23, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.12 CUBIC FOOT PER SECOND (IF AVAILABLE AT THE ORIGINAL POINT OF APPROPRIATION DESCRIBED AS BEING WITHIN THE SE 1/4 SE 1/4, SECTION 16, TOWNSHIP 25 SOUTH, RANGE 14 EAST, W.M.; 1000 FEET NORTH AND 60 FEET WEST FROM SE CORNER, SECTION 16), or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE 1/4 NE 1/4, SECTION 16, TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.; 152 FEET NORTH AND 75 FEET WEST FROM THE SE CORNER OF THE NE 1/4 NE 1/4 OF SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 NE 1/4 10.0 ACRES
SECTION 16
TOWNSHIP 27 SOUTH, RANGE 16 EAST, W.M.

When required by the Department the water user shall install an inline flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF APPROPRIATION AND PLACE OF USE approved by an order of the Water Resources Director entered MAY 30, 2001, and together with Certificate 78329 AND 80439, supersedes Certificate 52637, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
