## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

NORMA QUICK 78614 QUICK ROAD HERMISTON, OREGON 97838

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATION OF 25.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 106.2 ACRES.

This right was perfected under Permit 44614. The date of priority is AUGUST 23, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.64 CUBIC FEET PER SECOND for IRRIGATION and 2.65 CUBIC FEET PER SECOND for SUPPLEMENTAL IRRIGATION, or the equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW¼ SW¼, SECTION 16, T 4 N, R 28 E, W.M.; 660 FEET NORTH AND 10 FEET EAST FROM THE SW CORNER, SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or it's equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

#### NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

This certificate describes that portion of the water right confirmed by Certificate 55323, NOT modified by the provisions of orders of the Water Resources Director entered April 22, 2002, approving Transfer Application T-8992, an order entered August 7, 2003, approving Transfer Application T-8320, and an order entered August 7, 2003, approving Transfer Application T-8322.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
