CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ADEL WATER IMPROVEMENT DISTRICT

confirms the right to use the waters of DEEP CREEK AND TWENTY-MILE CREEK, tributaries of HART LAKE, for IRRIGATION OF 1728.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 1217.4 ACRES.

This right was perfected under Permit 34598. The date of priority is SEPTEMBER 29, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 73.73 CUBIC FOOT PER SECOND(CFS); BEING 48.19 CFS FROM DEEP CREEK AND 25.54 CFS FROM TWENTY-MILE CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

DEEP CREEK - SE 1/4 NW 1/4, SECTION 21, TOWNSHIP 39 SOUTH, RANGE 24 EAST, WM, 3130 FEET NORTH AND 2070 FEET EAST FROM SW CORNER, SECTION 21;

DEEP CREEK - SE 1/4 SW 1/4, SECTION 22, TOWNSHIP 39 SOUTH, RANGE 24 EAST, WM, 2700 FEET NORTH AND 1800 FEET EAST FROM SW CORNER, SECTION 22; AND

TWENTY-MILE CREEK - SE 1/4 SE 1/4, SECTION 24, TOWNSHIP 40 SOUTH, RANGE 23 EAST, WM, 900 FEET NORTH AND 550 FEET WEST FROM SE CORNER, SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

The use of water is subject to the provisions of a decree of the Circuit Court for Lake County entered October 13, 1954, concerning passage of water into Hart Lake.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
