## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of GREASER LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-1678, a tributary of WARNER LAKES, for IRRIGATION OF 1217.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 1278.2 ACRES.

This right was perfected under Permit 23218. The date of priority is OCTOBER 27, 1950. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 10,000 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

DAM LOCATION - SW 1/4, SECTION 17, TOWNSHIP 39 SOUTH, RANGE 25 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


