## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HUGH MALPASS 92969 COBURG ROAD HARRISBURG, OR 97446

confirms the right to use the waters of McKENZIE RIVER, a tributary of WILLAMETTE RIVER, for IRRIGATION OF 6.0 ACRES.

This right was perfected under Permit 50921. The date of priority is August 13, 1986 for 0.003 CUBIC FOOT PER SECOND (CFS) and October 2, 1986 for 0.07 CFS. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.073 CFS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

McKENZIE RIVER - NE 1/4 NE 1/4, AS PROJECTED WITHIN SPORES DLC 38, TOWNSHIP 17 SOUTH, RANGE 3 WEST, W.M.; 4440 FEET SOUTH AND 5250 FEET EAST FROM THE SE CORNER OF MANSFIELD DLC 79; AND

MUDDY CREEK RE-DIVERSION - SE 1/4 SW 1/4, AS PROJECTED WITHIN ROWE DLC 54, SECTION 12, TOWNSHIP 16 SOUTH, RANGE 4 WEST, W.M.; 1405 FEET NORTH AND 2730 FEET WEST FROM THE SE CORNER OF ROWE DLC 54.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SW 1/4 1.0 ACRE
SW 1/4 SE 1/4 5.0 ACRES
BOTH AS PROJECTED WITHIN ROWE DLC 54
SECTION 32

TOWNSHIP 15 SOUTH, RANGE 3 WEST, W.M.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review of the order must be filed within the 60 days of the date of service.

When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered OCTOBER 20, 1997, and along with Certificate 75439 and Order entered JANUARY 15, 1998, approving Transfer Application 7230, supersedes Certificate 75228, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

THIS CERTIFICATE IS ISSUED TO CORRECTLY DESCRIBE THE LOCATION OF THE REDIVERSION AND SUPERSEDES CERTIFICATE 80364.
